1. Yachimata City drunkenness fatal accident

In June 2021, five children were killed or injured in an accident in Yachimata City, Chiba Prefecture. A large truck driven by a drunk driver crashed into a concrete utility pole, shearing it off at the base, and then went another 40 meters while derailing the truck, plowing into a line of elementary school students on their way home from school.

The accident also brought into question the management system of the workplace, including a supervisor who failed to respond to repeated reports of the "smell of alcohol" from a subcontractor.

Yasutaka and Ikumi Inoue, who appeared in the video, are the bereaved families of victims of the Tomei Expressway drunk driving accident that occurred in 1999. The couple attended the criminal trial of the Yachimata case and contributed a detailed report to the quarterly magazine "Be!.

In addition, as an emergency project in conjunction with the general meeting in June of this year, the couple joined ASK representatives and other participants in a discussion on what can be done to prevent such accidents from happening again.

2. Request for Online Casino Regulation

Online casinos have attracted a lot of attention since the problem of erroneous money transfers in Abucho, Yamaguchi Prefecture.

One starts online casinos casually on the smartphone or other devices, gets addicted to the feeling of speed in seconds, finds oneself spending in the millions, and loses all sense of money because one sees there are just numbers......

The sheer magnitude of the experiences of these parties involved led some concerned parties to request that measures be taken as soon as possible.

A press conference was held on June 10, and on June 14, in the form of a caretaker meeting of the nonpartisan "Diet Members Caucus Against Addictions," a hearing was held at the request of the Diet members with representatives from related ministries and agencies.

4. Prefectural Plans for the Promotion of Measures Against Alcohol-related Health Harm

Based on the Basic Law on Measures against Alcohol-related Health Harm enacted in December 2013,

the national government's first basic plan, formulated in May 2016, set a goal for all prefectures to formulate a promotion plan by 2020.

Tottori Prefecture was the first prefecture in Japan to formulate a plan in 2015.

In October 2021, Wakayama Prefecture, the last prefecture to do so, formulated its plan, and after five and a half years, all prefectures in Japan finally have a plan for promoting measures against alcohol-related health problems.

The second phase of the plan has already been announced in some early areas. Hokkaido, Kyoto, and Tottori formulated their plans last year, and Saitama, Mie, Fukuoka, and Kagawa do so this year.

● Protest against "Sugoroku-attached" liqueur packs

The "Weiwei Land" demonstration videos by young YouTubers have been viewed more than 20 million times.

The product name indicates that it is a liqueur, not a game.

Sugoroku - the traditional Japanese board game played with dice - that accompanies the pack of 12 small 20-milliliter liqueur bottles has instructions for toasting more than half of the squares.

Even in the videos, it is hard to reach the goal, and the drinking continues endlessly.

The Liaison Council for the Prevention of Binge drinking, for which ASK serves as the secretariat, and others have lodged a complaint regarding this product. The Central Association of Alcoholic Beverage Industry informed the importer of the problem and received a response that the product would no longer be sold while supplies last.

We are still concerned about the effects of dangerous drinking videos made by YouTubes, which are popular among children.
